  - i) D.C's review

Who would have thought that 11 months after the last Review of Scouting in East Norfolk I would still be referring to the Global pandemic and effects of Covid-19? The impact for Scouting continues, with limited face to face meetings, still mostly outside, and no residential activities or District events possible. It is still amazing that Scouting is alive and working, thanks to all the dedicated Scouting adults in the District; that young people have kept connections and continued to achieve and develop those all-important Skills for Life that Scouting gives them.

Young people and leaders became familiar with County Box-Jams – a virtual 'box' of online activities, challenges, information and chat rooms accessed from our homes. The breadth of interest, fun and amusement was astonishing, and we all give grateful thanks to the County Programme teams for their diverse thinking and expertise in providing these events.

53 Young people have achieved their Top Award over the year, but we have not been able to acknowledge this within the District yet. Leaders continued to manage appropriate challenges within the restrictions and gave the young people a place to keep Scouting and feel supported.

As sections and Groups have returned to outdoor meetings, most leaders were concerned that there would be a huge drop in numbers judging by those that kept regularly with online options. I'm pleased to report that everyone has been pleasantly surprised that within 2 or 3 meetings the numbers have adjusted to nearer last year's figures and more have wanted to join Scouting.

There is a need therefore to plan for robust recruiting of adults to provide the right programmes to meet the needs of all those young people wanting to be part of Scouting.

Whatever the restrictions and changes society has to adapt to in the future, I'm confident that East Norfolk will continue to include determined, enthusiastic and motivated leaders actively sharing the values of Scouting to give the young people those Skills for Life – and enjoy great friendships with like-minded people themselves.

#### ii) Chairman's report

This is the second AGM we have held by Zoom and though it is nice to see you all I look forward to the time when we can meet face to face.

We have continued to meet as an Exec, as your Groups have done through the pandemic. Our meetings have tended to be how we can support Groups such that when Face to Face Scouting returns, we are in a position to help and support. I hope some of the measures we introduced such as reducing the district levy and paying the membership for Young Leaders this year have helped alleviate some of the difficulties of the Groups. Please ask if we can help to ensure the programme is available after the nastiness has receded.

In this time of change there are significant ones. Sheila Bakewell leaves us as treasurer, and we will say goodbye properly when we meet up again, but I would like to thank her on behalf of the District for her sterling work!

We will also be changing our District Commissioner soon as Jennifer's tenure runs out in the near future. I am hoping the Association will see sense and extend her term of office. She has brought much needed stability to the District and will be a hard act to follow! I would like to take the opportunity, if this is to be her last AGM to say thank you for all the work she has done. We are certainly in a better place.

If we change District Commissioner so we change District Chair and if this is the case this will be my last AGM, I would like to say thank you to my colleagues on the Executive who have faithfully attended meetings and contributed their time and expertise. I hope we have supported you as Scouters effectively and will continue to do so. As the nastiness of Covid recedes and we come together again please remember it is our first priority is to support you but we need to know where to target those resources.

Structure, governance, and management





East Norfolk District Scout Council is constituted in accordance with the Rules of The Scout Association to provide Scouting within Great Yarmouth and the surrounding area and is supported under those Rules by the Scout County of Norfolk. The Scout Association is incorporated by Royal Charter. The Charter of The Association provides for the making of Bye-Laws approved by Her Majesty in Council which, in turn, authorises the making of the Rules referred to above (known as "Policy, Organisation and Rules", or "P.O.R.").

The District is managed by the District Executive Committee. Its members are the Charity Trustees of the District Scout Council which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities, which includes registration, budgeting, keeping proper accounts and making returns to the Charity Commission as appropriate.

The District Executive Committee cannot act outside the Royal Charter, Bye-Laws and Rules of the Scout Association.

The District Executive Committee consists of a number of ex-officio members: District Chair, District Commissioner, District Secretary, District Treasurer, District Scout Network Commissioner, District Explorer Scout Commissioner and District Youth Commissioner; as well as elected, nominated and co-opted members. The County Commissioner and the County Chair have the right of attendance at meetings of the District Executive Committee.

The District Executive Committee exists to support the District Commissioner in meeting the responsibilities of the appointment and to provide support for Scout Groups, Explorer Scout Units and the District Scout Network in the District.

It is responsible for such matters as promoting the development of Scouting in the District; the maintenance of District property and administration of District finances; fund-raising; the appointment of Leaders, Administrators and Advisers; and appropriate insurance of persons, property and equipment.

The District Executive Committee may establish sub-committees.

Sub-Committees consist of members nominated by the Committee with the District Commissioner and the District Chair as ex officio members.

The District Scout Council is the electoral body, which supports Scouting in East Norfolk Scout District. It is the body to which the District Executive Committee is accountable. Membership consists of The District Chair, Secretary and Treasurer, The District Commissioner and all other members and Associate Members of The Scout Association including:

Vice Presidents and Vice Presidents (if any), Commissioners, Leaders, Section Assistants, Administrators, Skills Instructors, Advisers, members of the Scout Active Support Unit, and the Scout Network, including those with provisional appointments. All Explorer Scouts, and those parents/guardians of young people in the District who have notified the District Secretary that they wish to be treated as members of the District Scout Council. Members of the District Executive Committee, the County Commissioner, and the County Chair.

Other supporters of the District may be appointed as members by the District Scout Council on the recommendation of the District Commissioner and the District Executive Committee.

The District has systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss. These include two signatories or electronic authorisations required for all payments and relevant licences and insurance policies.



#### Public benefit

To be a charity in England and Wales, an organisation must have only charitable purposes which must be for the public benefit.

Trustees and the District Executive Committee have referred to The Charity Commission's general guidance on public benefit when reviewing the District's objectives and in planning future activities.

By adopting and maintaining the Purpose, Method and Values of The Scout Association, we are confident that our charitable purposes are sound, and in line with what we are trying to achieve in terms of public benefit for both our youth and adult members.

#### **Objectives and activities**

#### THE PURPOSE OF SCOUTING

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

#### THE VALUES OF SCOUTING

All Scouts are guided by the following values:

- Integrity they act with integrity; are honest, trustworthy, and loyal.
- Respect they have self-respect and respect for others.
- Care they support others and take care of the world in which they live.
- Belief they explore their faiths, beliefs, and attitudes.
- Co-operation they make a positive difference; co-operate with others and make friends.

#### THE SCOUT METHOD

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities; and
- make and live by their Promise.



#### Achievements and performance

#### Thoughts of the District Commissioner...

Since Jennifer passed on the East Norfolk baton in October 2021, the main priorities have been a focus on People, Perception and Programme.



**People:** The District Team has been strengthened and with the recruitment of two Deputy District Commissioners, two Youth Commissioners and an Assistant District Commissioner Beavers, with increased team to support night's away opportunities. Young Leader and Adult Training sessions have restarted, and a Local Training Manager is now in place to support all Leaders. Mark Daniels was co-opted as Executive Chair and has brought a re-focussed approach to governance.

**Perception:** A District Website launched and continues to build as a "one-stop" resource and information hub. Newsletters and regular Meeting Updates provide a high level of communication for all members. External media connections continue to be harnessed to promote Scouting and its value in society. The Summit saw 25 leaders and supporters take part in a day packed with skills sessions have the opportunity for review and development of the District Development Plan.

**Programme:** The launch of the D.C. Challenge award encourages everyone to engage with the issues that face our world and the community in which we Scout. District events have restarted and will continue to offer a wide range of activities over the coming months.

Sadly, one Scout Group was not able to re-open following the Covid pandemic, however the other ten Scout Groups, all five Explorer Units and the Active Support Unit are back to offering a wide range of Scouting opportunities to young people, including nights away adventures with more planned for the year ahead. My thanks for the welcome and support everyone has given in my first six months in post, especially to Jennifer for her support during the transition and for taking on various role to continue to be a valued member of the East Norfolk Scouting family.

#### DISTRICT MEMBERSHIP

The Scout Association's Annual Census at the end of January 2022 showed increases in total District membership to 455 members.

Youth membership (under 18's) increased by 25.2% to 400 whereas Adult membership dropped slightly by 3.7% to 155.

The Beaver section grew by 79.6%, which exceeded County growth of 47.1% and all other sections were in line with the County performance.

Other key measures to note:

Female Ratios:Youth Membership 120 female v 280 maleAdult Membership 85 female v 69 male

Disability: 57 members with registered conditions Ethnic diversity v area demographic: 4.5% v 14% (17 non- A1 youth members)

#### **RESPONSE TO COVID-19**

Following the suspension of face-to-face meetings in 2020 and 2021, Scout Groups and Explorer Units have returned to regular meetings. However, life after Covid-19 remains difficult for some Scout Groups and is likely to throw-up further challenges as we continue to rebuild in East Norfolk, our District will need to meet and overcome those challenges by everyone pulling together.

The pandemic has encouraged a move to online business meetings and this format is to be retained for most of the administrative functions of the District.

#### DISTRICT GOVERNANCE AND THE EXECUTIVE COMMITTEE

The District Executive Committee has continued to carry out its role responsibly and with due diligence and care. Its meetings have been moved to an online platform to reduce travel time and costs, and issues have been discussed and resolved in a thoroughly professional and business-like manner.

The District Appointments Advisory Committee has operated through the year using an online platform, which has been well received by new leaders due to the lessened impact on personal time.

There has also been an emphasis on training, encouraging Leaders to complete Wood Badges and ongoing updating of mandatory training to the standard required by the Scout Association.

## Plans for the future

The Vision is for East Norfolk District to provide to all Scout Groups and Explorer Scout Units support in the following areas:

- **Programme:** A fun, high quality programme, consistently delivered and supported by physical and simple digital tools and resources
- **People:** More well trained, better supported, and motivated adult volunteers, and more volunteers and young people from diverse backgrounds.
- **Perception:** Scouts is to be understood, more visible, trusted, respected, and widely seen as playing a key role in society today.

With specific and measurable targets of:

• **Growth:** Grow Youth membership to pre Covid-19 numbers: +123 on October 2021 Youth Headcount numbers (399 to 522) by census 2024. Grow Adult membership to pre Covid-19 numbers: +12 on October 2021 Adult numbers (160 to 172) by census 2024.

- People: Training compliance to achieve a consistent level of 95%: +18% on October 2021 compliance rate of 77% by end-year 2022 and ongoing. Increase of the number of young people achieving the spectrum of top awards from a total of 30 Top Awards in 2021 to a target of 25 Bronze, 20 Silver, 10 Gold and 5 Explorer or Young Leader Belt Awards (60) + 100% by end 2022.
- Inclusivity: Adult and youth membership reflecting the diversity of the local community (14% ethnic diversity in Great Yarmouth) by recruitment and retention of 6 adults to leadership / support roles and 21 youth members from the diverse communities that reside in East Norfolk by census 2025.
- **Community Impact**: Level of achievement of the DC Challenge Badge by district groups and units and subsequent media interest and impact in the community.

It is with pleasure I write this report to you all. Having taken over as Chair in January officially, I can only reflect on our recent achievement's.

Firstly, I would like to place on record our thanks to Miles Thomas, the previous Chair, for the work done over a number of years.

As an Executive Committee we have met twice in 2022 and the meetings have been really good, the enthusiasm of the Committee is inspiring, and I thank them for that. We look forward to new people joining us in the future to broaden our horizons of knowledge and skills.

Our new District Commissioner has brought a innovative energy to the District, along with her new team, we are in regular communication and there is a strong link between the Executive and District Management Team.

There are so many things to be positive about and look forward to in the development of Scouting in East Norfolk.
